WHAT IS THE PROGRAM? THERE ARE THOUSANDS OF HAITIAN IMMIGRANTS CURRENTLY LIVING IN BROOKLYN. LAST MONTH, THEY WERE GRANTED THE RIGHT TO TEMPORARY PROTECTED STATUS ("TPS"), WHICH MEANS THAT HAITIAN PEOPLE IN THE UNITED STATES ON THE DATE OF THE EARTHQUAKE ARE ABLE TO CONVERT THEIR ILLEGAL STATUS TO A LEGAL ONE. THEY CAN THEN WORK LEGALLY AND HOPEFULLY BETTER HELP THEIR FAMILIES IN HAITI. LAWYERS ARE NEEDED TO STAFF TEMPORARY LEGAL CLINICS AT WHICH WE WILL GIVE ADVICE ABOUT TPS AND ASSIST IN FILLING OUT APPLICATIONS.

HOW DO YOU VOLUNTEER? ALL YOU NEED TO DO IS ATTEND THE TRAINING **FEBRUARY 3** AT THE BROOKLYN BAR ASSOCIATION, 123 REMSEN STREET, BROOKLYN, NY 11201. THERE WILL BE A TWO-HOUR TRAINING SESSION, ATTORNEY SCREENING AND SIGN UP. VOLUNTEER ATTORNEYS MUST BE THERE FROM 5:30 TO 7:30 FOR THE TRAINING AND NEED TO COME EARLY OR STAY LATE FOR SCREENING AND SIGN UP. PLEASE COME WITH YOUR CALENDAR ANYTIME AFTER 4:00. YOU MAY REGISTER BY COMPLETING THE FORM ON THE REVERSE.

WHAT IS THE TRAINING? LAWYERS WILL LEARN GENERAL PRINCIPLES OF IMMIGRATION LAW, SPECIFICALLY FOCUSING ON TEMPORARY PROTECTED STATUS (TPS). WE WILL ALSO GIVE GUIDELINES FOR OTHER TYPES OF IMMIGRATION RELIEF FOR WHICH HAITIAN PEOPLE MAY BE ELIGIBLE. YOU WILL LEAVE THE TRAINING READY TO SPEAK WITH INDIVIDUAL CLIENTS ABOUT THEIR ELIGIBILITY FOR TPS AS WELL AS THE PROS AND CONS OF FILING AN APPLICATION. YOU WILL ALSO BE ABLE TO IDENTIFY OTHER AVENUES OF IMMIGRATION RELIEF THAT CLIENTS MIGHT NEED TO PURSUE. THE BBA VOLUNTEER LAWYERS PROJECT WILL ALSO DISCUSS THE LOGISTICS OF BEING A VOLUNTEER ATTORNEY, SUCH AS MALPRACTICE COVERAGE. YOU WILL RECEIVE 2 HOURS OF CLE CREDIT THROUGH BROOKLYN DEFENDER SERVICES, AN ACCREDITED CLE PROVIDER.

WHAT IS THE LEGAL CLINIC? VOLUNTEERS WILL BE WORKING IN GROUPS. EACH GROUP OF ATTORNEYS WILL BE ACCOMPANIED BY EXPERT IMMIGRATION ATTORNEYS TO ANSWER QUESTIONS. THERE WILL ALSO BE REPRESENTATIVES FROM BROOKLYN DEFENDER SERVICES TO HELP ANY CLIENT WHO HAS A CRIMINAL CONVICTION. THERE WILL BE OTHER SERVICES AVAILABLE AS WELL, INCLUDING SERVICES FOR PEOPLE WHO MAY BE ABLE TO APPLY FOR VISAS, POLITICAL ASYLUM OR OTHER FORMS OF LEGAL STATUS.
