OCAD

 Organized Communities **Against Deportations** (OCAD) is an undocumented-led group that organizes against deportations, detention, criminalization, and incarceration, of Black, brown, and immigrant communities in Chicago and surrounding areas.





How do we organize & support people in deportation proceedings?

- · Help individuals and family navigate and understand process
- · Connect with legal support, and help make case stronger
- · Help gather personal documents and support/ proof
- Support in framing of the story for the public & for ICE
- · Connect case to civil rights and policy issues
- · Getting support from national institutions
- Helping stop a physical deportation







OCAD - Case Strategy Practice:

- How do you make the case stronger?
- What sort of public messaging or frame will you use for the case? [What's the headline? What's the injustice?]
- · Who are your allies, likely and unlikely?
- What strategies can you use to stop their deportation?

Collective Lessons Learned

- · Create a media communication plan
- · Streamline communication
- Center litigation strategy and planning around the voices of those directly impacted
- Be willing to think creatively and translate "non-legal" ideas into legal possibilities
- Determine compatible levels of aggression for the organizing and legal strategy
- · Strategically disrupt the judicial process



Collective Lessons Learned

- Organizers need transparency from legal team
- · Take the time to train one another
- Be prepared for the worst case scenario and don't be afraid to ask questions
- Be honest about your limitations but also committed to learning
- · Create trust, hang out, with one another
